

Announcement on Manufacturer Recruitment of Clothes and Accessories for Volunteers and Other Workers of World Expo 2010 Shanghai

In order to better publicize World Expo 2010 Shanghai China (hereinafter referred to as Shanghai Expo), and enable more excellent enterprises to participate in and serve the Shanghai Expo, as well as to satisfy needs of a wide range of expo volunteer for purchasing of clothes and accessory of the Shanghai Expo, it is planned to recruit the candidate manufacturers of clothes and accessories for World Expo 2010 Shanghai according to the general plan of World Expo 2010 Shanghai, so as to complete manufacturing of clothes and accessories for the volunteers and other workers.

For this reason, the Bureau of Shanghai World Expo Coordination (hereinafter referred to as "BSWEC") publicly recruits candidate manufacturers of clothes and accessory in mainland China, hereby publish this recruitment announcement.

I. Project Profile

1. Project name: Announcement on Manufacturer Recruitment of Clothes and Accessories for World Expo 2010 Shanghai
2. Project contents: To manufacture clothes and accessories for volunteers and other workers of World Expo 2010 Shanghai, including T-shirts, trousers, skirts, western style suits, formal dresses, shirts, caps, neckties, knapsacks, belts, leather shoes, towels, raincoats, badges, etc.

II. Recruitment Categories and Objects

This recruiting practice is oriented to the Chinese mainland, with recruitment objects orientated as established and registered independent enterprise legal persons continuously existing according to the law within the territory of the People's Republic of China.

IV. Qualification of the Applicant

1. Legally established and registered independent enterprise legal persons within the territory of the People's Republic of China, with a registered capital of over RMB 10,000,000 Yuan (inclusive).

3. With good business reputation, without any occurrence of significant legal proceedings that affect business operations.
4. With a healthy financial status, without bad credit records.
5. Pass the ISO9000 Quality System Certification.

6. Over past two years, have no negative report and punishment by commerce and industry department or quality and technology supervision department.

V. Application Period

Applicants shall submit the application documents and materials to BSWEC (Room 217, Building 1, No. 3588, Pudong South Road) from the date of issuance of this recruitment announcement by 17:00 of on Sept. 30, 2009 (Beijing time). Overdue application will be rejected.

VI. Recruiting Procedures

1. According to the requirements of recruitment announcement, the applicants are required to deliver to BSWEC the recruitment documents, business licenses, Organization Code Certificates, Credit Letters, ISO9000 certificates, copies of audited financial statements and audit reports of last two years, original of Letter of Commitment (to promise that there are no major legal proceedings, which influence business operations, negative reports or punishment by industry & commercial, or quality technology supervision departments) (sealed affixed, with A4 paper).
2. BSWEC shall review the application documents, and finally determine the list of selected candidate manufacturers of clothes and accessory.
3. If data provided by applicants are incomplete or improperly bound, the Bureau of Shanghai World Expo has the right to reject application documents.
